Traders Trust is the trading name of Traders Trust group of Companies, hereinafter referred to as “Traders Trust” and “the Company”.

Traders Trust Ltd is a company incorporated under the laws of Seychelles with Registration Number 8429440-1, having its registered address at CT House, Office 9A, Providence, Mahe, Seychelles. Traders Trust Ltd is authorised and regulated by the Financial Services Authority (FSA) as a Securities Dealer, holding Securities Dealer License SD141.

TRADERS TRUST Traders Capital Limited is a limited liability company incorporated in Bermuda under section 14 and 6/132C(1) of the Companies Act 1981, registered with the Registrar of Companies under Company Number 54135, registered at 5th Floor, Andrew's Place, 51 Church Street, Hamilton HM 12, Bermuda.

The Company is operating in accordance with the above-mentioned Laws.

1. RISK DISCLOSURE STATEMENT & DISCLAIMER

Before you proceed the completion and submission of your Request to subscribe to the Traders Trust Copy Trade Signal Distribution Service, you should carefully read, understand and acknowledge the following Risk Disclosure Statement & Disclaimer:

- You expressly acknowledge, agree and fully understand that the Traders Trust Copy Trade Signal Service is a service offered by us via a software application that is designed to technically implement and automate copying processes occurring between (i) a Master MT4 Account, which is opened and operated via our MT4 Trading Platform by you as the Signal Provider and which sends trades and orders, and (ii) one or more Slave MT4 Accounts, which are opened and operated via the Company's MT4 trading platform by one or more third party Signal Subscribers and which are receiving the trades and orders from your Signal Provider's Master MT4 Account; as such the TRADERS TRUST Copy Trade system is an auto-trading system, whereby your Signal Provider's Master MT4 Account and the Slave MT4 Account(s) of the Subscribers to your trading Signals communicate all the time and synchronize all settings and data in real time (copying the trades and movements from your Signal provider's Master MT4 Account to the Slave MT4 Account(s) of the Subscribers to your trading Signals); our MT4 Trading Platform receives Trading Signals from your Signal Provider's Master MT4 Account; once the signal is received, we validate the signal only for the purpose of verifying whether it is consistent with the third party Signal Subscriber's Slave MT4 Account settings and preferences; if the signal is accepted, we send the trading signal to the he third party Signal Subscriber's Slave MT4 Account for execution.
- In that regard, you acknowledge and agree that copy trading relies on technology and technology does not always work the way it is supposed to and **you expressly acknowledge, agree and fully understand that using the Traders Trust Copy Trade Signal Service for the distribution of your Trading Signals exposes you to risks associated with the use of computers and data feed systems relied on by us to perform the Traders Trust Copy Trade Signal Service, which may include, but are not limited to, failure of hardware, software or communication lines or systems, delays in our systems processing requests for the execution of orders and/or inaccurate external data feeds provided by third-party vendors.** Accordingly, implementation of Trading Signals/failure to implement Trading Signals in the Signal Subscriber's Slave MT4 Accounts of the Subscribers to your trading Signals via the Traders Trust Copy Trade System can result in differences between the results in your Signal Provider's Master MT4 Account and the results in the Signal Subscriber's Slave MT4 Accounts of the Subscribers to your trading Signals; furthermore, differences in trading conditions in your Signal Provider's Master MT4 Account and in the Signal Subscriber's Slave MT4 Accounts of the Subscribers to your trading Signals can jeopardize the possibility of implementing Trading Signals; communication failures can lead to missed Trading Signals.

Absent wilful or wanton misconduct, neither we (nor any of our directors, officers, employees and agents), nor any of our Affiliates (nor any of their respective directors, officers, employees and agents), nor any authorized carriers, will be liable for any such breakdowns or failures.
