

## LIMITED POWER OF ATTORNEY

### Managed Account Authorisation and Risk Disclosure

A Customer who designates a Money Manager is defined as any person other than the Customer who is given the ability to control, manage or direct trading decisions in the Account (see definition below), must read and agree to the following document by signing and dating before Authorization will be granted by TTCM Traders Capital Limited (herein "Traders Trust").

The Undersigned Customer(s) authorizes as follows:

I/we designate  
(referred to as " \_\_\_\_\_ ), as Money Manager and attorney-in-fact for the purpose of buying and selling margined foreign currency lots for the undersigned Customer's Account (the "Account"), and at the Customer's sole risk through Traders Trust. The Customer hereby indemnifies and holds harmless Traders Trust for losses, indebtedness and all other liabilities that arise directly or indirectly thereof.

The Customer acknowledges and understands that Traders Trust is hereby given authorization to follow the instructions of the authorized Customer's Money Account Manager (the "Account Manager" or "MAM") in every respect with regard to the Customer's foreign currency trading Account with Traders Trust, except for the non-trading withdrawal of any money, securities, collateral or any other asset that is in the name of the Customer.

Traders Trust will not in any way be liable or responsible for any buy or sell trading actions done on the Customer's behalf by the Money Manager or for any losses incurred by the Money Manager for the Customer's Account. Further, Traders Trust does not endorse the Agent nor does it vouch for the background, or experience of the Customer's Trading Agent, nor does Traders Trust endorse any operating methods used by the Customer's Money Manager, including when trading for the Customer's Account.

Please be advised that Traders Trust permits your designated Money Manager to charge a commission or provide the Money Manager with monetary compensation for purchases and sales done on behalf of the Customer's Account on a per trade basis, if managing your account under a limited power of attorney.

The Customer acknowledges, assents and understands that the above authorized Money Manager will have access to and be given copies of any statements, notices and correspondence relating to the Customer's Account and that the Money Manager is hereby given authorization to acknowledge and approve the correctness of any such statements and other documentation on behalf of the Customer.

It is the Customer's duty to and/or monitor all activity and Account information and should contact Traders Trust with any questions. Traders Trust will endeavor to provide the Customer with online access to all Account information including, but not limited to, the Cash on Account, Unrealized Profit and Loss on Open Positions, Account Value, as well as a record of all prior trade details including but not limited to Realized Profit and Loss, the Date of the Transaction, Amount and Deal Price.

The Customer acknowledges and understands that trading in margined foreign exchange is very

risky and may result in losses that are equal to or exceed the amount of margin deposited with Traders Trust. The Customer should only trade or give authorization to trade on the Customer's behalf, risk capital, which is defined as that capital which if lost would not alter the lifestyle of the Customer, the Customer's family and/or the solvency of the corporation for which the Customer or Customer's Authorized Money Manager trades.

The Customer acknowledges that neither Traders Trust nor any Money Manager can guarantee profits or avoid the risk of loss or, under some circumstances, even limit the extent of the potential loss. The Customer is solely and exclusively responsible for understanding the trading objectives and risks of the Money Manager and acknowledges and agrees that Traders Trust is not responsible for any transactions that may or may not conform to those objectives. By granting Trading Authority, the Customer understands that Traders Trust does not endorse or vouch for any Money Manager's objectives or to any representations that the Money Manager may claim or make to the Customer.

**The Customer Acknowledges that past performance is not a guarantee, nor indicative of future returns, as returns may vary according to market conditions.**

The Customer acknowledges and understands that Money Manager Authorization will cease only upon written revocation by the Customer or by the Money Manager who is given the Authorization. Revocation for whatever reason shall not effect or limit the obligations and liabilities resulting from transactions or contracts that were initiated before the effective date of revocation.

The Customer acknowledges that the Customer has read and understands the [Traders Trust Risk Disclosure for Financial Instruments & Investment Services](#) document and agrees to all its terms.

Traders Trust does not control, cannot endorse or vouch for the accuracy or completeness of any information advice or product you may have received or may receive in the future from a Money Manager. Moreover, Traders Trust does not endorse or vouch for the services provided by the Money Manager. It is your sole responsibility to properly evaluate the Money Manager before engaging to their services.

Traders Trust will hereby facilitate the instructions set forth herein without further direction or confirmation on your behalf, unless otherwise notified in writing. Notwithstanding the foregoing, if I request a withdrawal and/or transfer from my Account(s), and there are insufficient funds available to pay the person(s) or entity/entities specified and/or referred to herein the Performance Fee specified and/or referred to herein as a result of such request or other action taken by me, I understand that such request may not be processed for the full amount requested and agree that I shall remain obligated to make payment to the person(s) or entity/entities specified and/or referred to herein for any payments due pursuant to the agreement between me and the person(s) or entity/entities specified and/or referred to herein. Traders Trust shall not be held responsible or liable for any miscalculation or non-payment of said Performance Fee for any reason whatsoever. The Performance Fee will be charged on the Net Equity gain/losses, net of trading and other commissions taking into account all realised and unrealised gains and losses.

This authority shall continue to have effect until the Customer shall submit a written instruction sent by email to [support.int@ttcm.com](mailto:support.int@ttcm.com) amending or revoking this Limited Power of Attorney form. Any such amendment or termination shall not affect

- (a) any previous Instruction or Orders received from my Money Manager; and
- (b) any obligation of Traders Trust to pay any sums due to my Money Manager in respect of any transactions initiated, in either case prior to such amendment or revocation instruction taking effect.
