

## 利用規約「30%入金ボーナス」

TTCM Traders Capital Limited（以下「当社」または「Traders Trust」「弊社」）は、Bermuda法（Companies Act 1981）第14条に基づき設立された有限責任会社であり、会社登録番号54135にて正式に登録され、本社所在地は Penthouse level, 5 Reid Street, Hamilton, Pembroke, Bermuda HM11です。

本「30%入金ボーナス」利用規約（以下「本プロモーション」「本ボーナス」）は、「TTCM参加者契約－取引規約」の一部を構成し、同契約の付属条項として適用されます。

1. Traders Trustの「30%入金ボーナス」（以下「本プロモーション」「本ボーナス」）は2025年9月1日より開始し、2025年10月31日まで実施されます。ただし、当社の判断により期間が変更される場合があります。
2. 本プロモーションは、「Classic Bonus」口座を新規に開設し、30%入金ボーナス申請フォームを提出のうえ承認され、2025年9月1日以降に任意の対応通貨で初回入金を行ったすべての登録済み参加者（以下「参加者」）を対象とします。

## Terms & Conditions “30% Deposit Bonus”

TTCM Traders Capital Limited (hereinafter “Company”, “Traders Trust”, “We”, “Us”) a limited liability Company, incorporated in Bermuda under section 14 of the Companies Act 1981 and registered with the Registrar of Companies under Company number 54135, with registered address Penthouse level, 5 Reid Street, Hamilton, Pembroke, Bermuda HM11.

The present Terms and Conditions (hereinafter “30% Deposit Bonus”) forms an integral part of the “TTCM Participant Agreement – Terms & Conditions of Business” and provisions set herein are considered as an Annex of all “TTCM Participant Agreement – Terms & Conditions of Business”.

1. Traders Trust’s 30% Deposit Bonus (hereinafter “Promotion”, “Bonus”) begins on the 01/09/2025 and will run until 31/10/2025, until Traders Trust determines otherwise.
2.
