

Traders Trust Free Trading Competition Terms & Conditions

1. General

1.1 The Traders Trust Free Trading Competition (the "Competition") is organised by Traders Trust. Traders Trust is the trading name of Traders Trust group of Companies, hereinafter referred to as "Traders Trust" and "the Company".

1.1.1 Traders Trust Ltd is a company incorporated under the laws of Seychelles with Registration Number 8429440-1, having its registered address at CT House, Office 9A, Providence, Mahe, Seychelles. Traders Trust Ltd is authorised and regulated by the Financial Services Authority (FSA) as a Securities Dealer, holding Securities Dealer License SD141.

1.1.2 TTCM Traders Capital Limited is a limited liability company incorporated in Bermuda under section 14 and 6/132C(1) of the Companies Act 1981, registered with the Registrar of Companies under Company Number 54135, with registered address at 5th Floor, Andrew's Place, 51 Church Street, Hamilton HM 12, Bermuda.

1.2 Registration for this Competition and/or entry in the Competition constitutes your agreement to these Rules and you will not be eligible for the prize unless you agree to these Rules.

1.3 The Competition is conducted exclusively in a demo trading environment and does not involve real funds.

1.4 The Competition is organised for promotional and educational purposes only and does not constitute investment advice.

2. Eligibility & Participation

2.1 Only persons of legal age (18 or older) and who are able to meet the criteria of opening a live account with the Company for regulatory and compliance purposes can take part in the Competition. Participants who do not meet the criteria for opening a live account with the Company shall be disqualified and the Company shall reserve the right to withhold the prize and award another trader as per the conditions of the Competition.

2.2 Each participant agrees to provide real data (accurate, complete, and truthful information) during registration. Providing fake data may result in disqualification from the Competition at any stage.

2.3 Employees of Traders Trust, its affiliates, partners, or any parties involved in the administration of the Competition, including their immediate family members, relatives, household members, or close associates, are not eligible to participate.

2.4 Each client may participate only once per Competition. Multiple registrations or accounts are not permitted. Users participating in the contest who have more than one profile and open or operate multiple competition accounts will not be entitled to receive any prizes.

2.5 Winners may be required to register a live trading account directly with Traders Trust, if they do not already hold one.

2.6 Prior to prize delivery, winners may be required to successfully complete KYC (Know Your Customer) verification, in accordance with applicable laws and internal compliance requirements.

2.7 Failure to complete account registration or KYC verification may result in prize forfeiture.

3. Competition Period

3.2 The start and end dates of each Competition period will be announced on the Traders Trust website, client portal, or promotional materials.

3.3 Registration is only available by completing all required steps as outlined on the Traders Trust Trading Competitions dedicated website page.

3.4 Only trades executed within the official Competition period will be considered for ranking.

4. Trading Conditions

4.1 Participants will be provided with a VIP demo trading account with:

- A predefined virtual balance of 10,000 USD
- Leverage: up to 1:3000
- Trading Instruments: Forex, Metals, Indices, Commodities, Cryptocurrencies
- Trading via Expert Advisers (EAs) is permitted; however, the Company reserves the right to review, restrict, or disqualify any automated trading strategy that, in its sole discretion, is deemed abusive, exploitative, latency-based, arbitrage-driven, or inconsistent with fair competition principles.

4.2 Subject to the Company's rights under these Terms and Conditions, if you meet the eligibility requirements and the participation criteria, your participation will be valid.

4.3 Participants will be ranked based on the percentage return (%) achieved on their demo account by the end of the Competition period.

4.4 The participants with the highest % in profit equity who also adhere to all other conditions set herein shall be announced as winners. Participants with a negative % performance will not be eligible for prizes regardless of their ranking.

4.5 All trading activity must be conducted exclusively on the assigned demo account.

5. Winner Notification & Prize Claiming

5.1 Winners will be notified via the registered email address associated with their Traders Trust profile within one (1) week approximately seven (7) days following the conclusion of the Competition.

5.2 Winners must respond to the notification and complete any required steps to claim their prize within one (1) week approximately seven (7) days of being contacted.

5.3 If a winner fails to respond within this timeframe, the prize may be forfeited, and all rights to the prize shall be deemed waived.

5.4 In the event of forfeiture, Traders Trust reserves the right to reassign the prize to another eligible participant or cancel the prize at its sole discretion.

6. General Rules

6.1 The Company reserves the right, in its sole judgement and discretion which will be final and binding, to reject or disqualify any participant who is breaching the terms set herein and, in all cases, when the Company has reasons to believe that the contestant is engaged in fraudulent or otherwise unfair trading methods/practices including but not limited to:

6.1.1 Any kind of IP match between two or more participants shall be grounds for disqualification.

6.1.2 Any kind of hedging between accounts or participants shall be grounds for disqualification.

6.1.3 Any kind of arbitrage trading, and/or any other abuse with pricing and/or quotes will be subject to disqualification from the Competition.

6.1.4 Any kind of trading patterns suggesting that the participant is solely seeking financial gain from the promotion without a genuine interest in market trading and/or taking market risks are strictly prohibited.

6.2 Disqualified participants forfeit any entitlement to prizes.

6.3 Trading results achieved in the Competition are based on simulated market conditions and are not indicative of results achievable in live trading environments.

6.4 The Company shall not be liable for any technical failures, system errors, platform interruptions, data inaccuracies, or circumstances beyond its reasonable control that may affect participation, trading results, rankings, or prize allocation.
